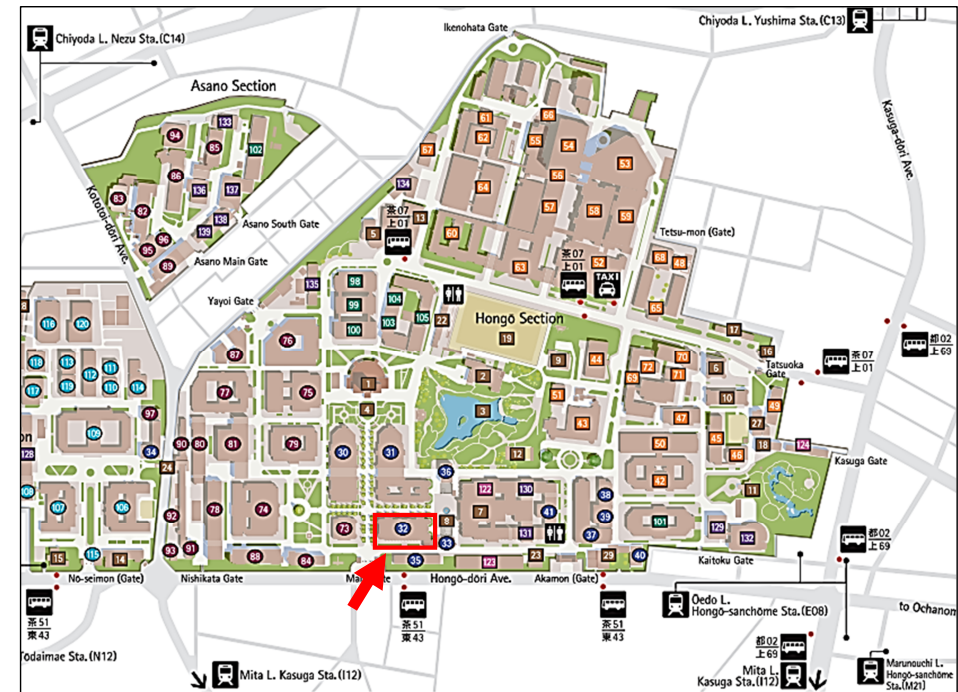

Prof. Dr. Shigeto Yonemura is a professor of civil law and medical law at the Faculty of Law, University of Tokyo. He is also a physician and works in a hospital as a cardiologist. His research topics include general theories of tort liability, product liability, medical malpractice, regulation of biomedical research, disaster liability, and protection of privacy. Recently, he has analyzed the legal conflict of privacy and infection control during the pandemic. From such viewpoint, he is involved in the RE-CARE network as a collaborating researcher.

Assoc. Prof. Dr. Susanne Brucksch is a scholar of Japanese Studies and Social Sciences at the Department of Global Japanese Studies of Teikyo University in Tokyo. Her research focusses on health technologies, innovation research, relationship of technology and society, civil society and policy studies. In 2021, she published the edited volume "Humans and Devices in Medical Contexts. Case Studies from Japan" together with Prof. Kaori Sasaki, Sapporo Medical University. At present, she has been researching med-tech partnerships between hospitals and medical device manufactures in Japan. From such viewpoint, she participates in the RE-CARE network as a collaborating researcher.
